The intended use of this material is for the verification of test analysis by the above listed or other valid methods. The precision value represents the expanded degree of uncertainty based on errors from analytical assay by a consensus of ISO 17025 accredited labs, at a 95% confidence level (k=2) utilizing ANOVA, ISO Guide 35, and the Guide to Uncertainty Measurement. When necessary, professional judgment is applied toward consideration of data and statistical information. The statistical analysis and the overall direction and coordination of the analytical measurements leading to certification were performed by K.E. Dyer Chief Chemist at Alpha Resources. Normal testing procedures should be employed when using this standard; this includes using the *reproducibility* and *repeatability* factors based upon your test method.

The samples for round robin testing were selected in accordance with ARI 031. The above values relate only to the material used to produce this standard. The analytical samples are recommended to be dried per the test method used. This bottle contains 50g, fine -60 mesh (250u) green petroleum coke powder. While unable to determine a definite shelf life this reference should be reviewed every 20 years from date of certification. Once opened this certificate is valid for 2 years.
