The statistical analysis and the overall direction and coordination of the analytical measurements leading to certification were performed by K.E. Dyer, Chief Chemist at Alpha Resources.

The material used in production of this standard was identified in accordance with ARI-LAB-603. The samples for round-robin testing were selected in accordance with ARI-LAB-625. The above values relate only to the material used to produce this standard. The analytical samples should be dried or corrected for moisture as per the test method you are using. This bottle contains 50g fine coke powder (-60 mesh). While unable to determine a definite shelf life this reference standard should be reviewed 20 years from the date of certification. Once opened this certificate is valid for two years. Keep sealed tight and store under normal laboratory conditions. This certificate cannot be reproduced except in full. Remedies for any claimed defect in this product will be limited to product replacement or refund of the purchase price.
