This pin reference standard is intended to be a calibration or QC validation of Oxygen and Nitrogen on inert gas fusion analyzers utilizing infrared and thermal conductivity detection as described in ASTM E1019. The analytical sample and minimum size used for testing was 1 pin (0.5g nominal). The precision values represent the estimated mean, standard deviation, and expanded uncertainty derived from using ISO Guide 35, ANOVA, and the Guide to Uncertainty Measurement. Metrological traceability is to the SI derived unit of mass fraction expressed as percent. Refer to your test method and or your instrument manufacturer for the expanded method derived uncertainty. When necessary, professional judgment is applied toward consideration of data and statistical information. The statistical analysis and the overall direction and coordination of the analytical measurements leading to certification were performed by K.E. Dyer, Chief Chemist, at Alpha Resources.
