This pin reference standard is intended to be a calibration or QC validation of Oxygen and Nitrogen on inert gas fusion analyzers utilizing infrared and thermal conductivity detection as described in ASTM E1019. The analytical sample and minimum size used for testing was 1 pin (0.5g nominal). The precision values represent the estimated mean, standard deviation, and expanded uncertainty derived from using ISO Guide 35, ANOVA, and the Guide to Uncertainty Measurement. Metrological traceability is to the SI derived unit of mass fraction expressed as percent. Refer to your test method and or your instrument manufacturer for the expanded method derived uncertainty. When necessary, professional judgment is applied toward consideration of data and statistical information. The statistical analysis and the overall direction and coordination of the analytical measurements leading to certification were performed by K.E. Dyer, Chief Chemist, at Alpha Resources.

The material used in production of this standard was identified in accordance with ARI-LAB-603. The samples for roundrobin testing were selected in accordance with ARI-LAB-625. The above values relate only to the material used to produce this reference standard. This reference contains 50g, 0.5g pins (nominal), to be used directly from the bottle with no preparation. While unable to determine a definite shelf life, this reference should be reviewed every 25 years from the date of certification. Keep sealed and store under normal laboratory conditions. This reference material was produced in accordance with ISO 17034 and ISO Guide 31.
